They are an Edmonton based program that promotes health (mental wellness, healthy eating, and physical activity) in over 100 schools throughout BC, Alberta, Manitoba and Ontario since 2007.

# School Board Trustee Report – Joan Nellis

- Our board gave the first reading to a bylaw that will require any candidates for Trustee in the next election to submit a criminal record check with their nomination papers. We will be giving second and third reading to this bylaw in December, if you want to learn more or have an opinion on this, please reach out to me soon.
- We heard from Director Therrien on the division's annual attendance report. There was a lot of information in there, and I am sure you've noticed the Division Attendance Matters campaign on social media. Attendance in some areas is an ongoing issue. We were pleased to hear that last year we saw an increase of approx. 500 students in the 90% or better attendance range, this represented a 5% increase.
- In addition to our capital plan, the Division just requested some modular classrooms from the province to address pinch points at the Comp and Isabel Campbell. This does not mean we will get the rooms, but those 2 schools need relief, so we are hoping that the province will allocate some to us.
- We had our council of school councils meeting on the 28th. Thanks for Forbes reps for attending. They can speak to the meeting but if you have questions, I can answer in next time. We shared information on enrollment, budget, and our new advocacy priorities and discussed January's meeting. January will be a PD meeting. We will share some more details with this group once we get everything together.
- We approved our annual audited financial statement. We are proud to have another clean audit. We had planned for a deficit of \$2.5m but with midyear unexpected funding and a shortage of staff (hiring subs and EA's), and better than expected interest on investments, we ended up having a surplus of around \$700,000. This is a good problem, but still a problem. Our Board has a 3-year budget where we attempt to spend money from today on today's students, while saving for unexpected and planned projects. Our work on priorities will guide this work. We expect a new funding formula from the government in the new year so we will need to adjust our plan again once we have details on that.
- We also approved our Annual Education results report. This is something we are required to send the government yearly. It shows our academic results and gives some background on changes and adjustments we are making because of them. It will be posted on our web site it you are interested.
