Information

- Possible job action:
 - We know there are a lot of questions about the possibility of a strike or lockout. We don't have any information that isn't in the press. We will continue to provide a safe and welcoming environment for our students while we hope that the Central Table Bargaining Committee (CTBC) and the Teachers' Employer Bargaining Association (TEBA) are able to come to an agreement that best supports our students.
 - Both sides are required to give 72 hours' notice.
- New Gov't Legislation Impacting Schools:
 - o Standards for the Selection, Availability, and Access of School Library Materials
 - Ministerial Order 030/2025 was paused after the Edmonton Public School Board released a list of books that they would be removing from their libraries to comply with the order.
 - A new order was released on September 8th. It addresses explicit graphic depictions of sexual content. Our division will be developing an AP that addresses how we will respond and comply with the new order.
 - The books that were behind the initial legislation are not nor have they ever been in GPPSD schools.
 - If you ever have questions about a title in our schools or in your teacher's classroom library, please let us know.
 - Bill 29: Fairness and Safety in Sport
 - Declaration for all female athletes in the province who are 12-17.
 - Bill 27: Amendments to the Education Act
 - Sexual Orientation and Gender Identity: Staff must notify parents and get written consent before using a different pronoun or name with a student.
 - Human Sexuality Instruction:
 - Rather than opting out, parents must now opt in to instruction.

- Parents can choose which outcomes for which they want their children to participate.
- The division is currently creating APs to address the new processes and procedures required by this legislation. These will be shared on our public web page once they are finalized.

Student Nutrition Policy

1. Purpose

The purpose of this policy is to promote student health, wellness, and academic success by encouraging healthy eating habits and providing a supportive environment. This policy outlines expectations for nutrition practices within the school and establishes guidelines that align with the Alberta Physical Education and Wellness curriculum.

2. Scope

This policy applies to all students, staff, parents/guardians, and visitors at Alexander Forbes School. It governs nutrition-related practices during instructional hours, breaks, and school-sponsored activities held on school property.

3. Policy

3.1 Healthy Role Modelling

Staff are committed to modelling and teaching healthy eating habits as part of daily practice. Nutrition education is embedded in the school experience to help students develop lifelong healthy habits.

3.2 Respect for Families

Students will not be criticized or singled out for the food they bring to school. The school recognizes that families make food choices based on a variety of needs and circumstances.

3.3 Classroom Beverages

- Only water is permitted in classrooms, except during lunch or designated nutrition breaks.
- Energy drinks are not permitted at any time.

3.4 Eating Times

- Students will have scheduled opportunities to eat at both nutrition break and lunch each day.
- Additional snacks are permitted as needed to support student learning and well-being.

3.5 Instruction

All teachers are responsible for teaching healthy eating as part of the Alberta Physical Education and Wellness curriculum. Instruction will emphasize balanced nutrition, positive choices, and the relationship between food, energy, and overall wellness.

3.6 Family Partnership

Parents/guardians are encouraged to contact their child's teacher if they require support with providing food or have questions about nutrition at school. The school is committed to working collaboratively with families to support every student's needs.

3.7 Equity and Access

The school is committed to ensuring that all students have access to food throughout the school day. Healthy snacks and lunches are made available, and discreet support will be provided to students who may arrive at school without food. No child will be left hungry during the school day.

3.8 Food Allergy and Sharing: Safety Considerations

For the safety of all students, food sharing is strongly discouraged. Staff and students are expected to be mindful of food allergies and dietary restrictions, which may include—but are not limited to—nuts, gluten, pork, and other common allergens. Teachers will communicate classroom-specific allergy considerations to families, and parents are asked to support these safety measures.

4. Implementation

- Teachers will incorporate healthy eating instruction within the Physical Education and Wellness curriculum.
- Staff will monitor compliance with beverage and nutrition break guidelines.
- Administrators will provide ongoing communication to families to ensure clarity and support.
- Discreet systems will be in place to provide food access for students who need it.
- Allergy and dietary restrictions will be shared with staff and reinforced through safe classroom practices.

5. Review

This policy will be reviewed every three years, or sooner if required by updates to division guidelines, provincial curriculum changes, or school community needs.
